Image Reproduction Agreement

1. All requests for reproductions of images from the West Virginia and Regional History Center (WVRHC) must be submitted using the Image Reproduction Request Form.

• A completed Image Reproduction Agreement form and full payment is required before copies will be released. Permission for reproduction is contingent on the completion of this form, is limited to the patron, and is non-transferrable.

2. All reproductions are provided for a one time, non-exclusive basis. The WVRHC does not grant open-ended permission for future uses, and never grants exclusive rights.

3. In instances when WVRHC images are used in publications, films, or exhibits, etc.... Credit must be given using the following credit line:

West Virginia and Regional History Center WVU Libraries

- For print publications, crediting of each item at its point of use is mandatory in all cases, unless an exception is granted in writing.
- For audio-visual productions, credit can be listed with other sources of illustrations. For printed material accompanying audio-visual productions, credit at the point where the illustration is discussed.
- For exhibitions, credit within the exhibit area.

4. The WVRHC will be given one complimentary copy of any publication or audio-visual production in which our photographs or still images appear. Exceptions may be made for productions of exceptional expense, but must be agreed to and noted in writing.

5. Copyright Concerns: The WVRHC does not hold the copyright for many of the items in its collections. The WVRHC cannot, does not, and will not warrant or represent that it owns all rights to images within the WVRHC. Responsibility for determining if additional permissions are needed from rights holders for use of images and for securing permissions in regard to matters including but not limited to copyright and invasion of privacy is assumed by the patron requesting the materials.

Warning Concerning Copyright Restrictions

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material. Under certain conditions specified in the law, archives and libraries are authorized to furnish a photocopy or reproduction. One of these specified conditions is that the photocopy or reproduction is not to be "used for any purpose other than private study, scholarship or research." If a user makes a request for, or later uses, a photocopy or reproduction in excess of "fair use," that user may be liable for copyright infringement. 9. The WVRHC reserves the right to: limit the number of visual images copied; to restrict the reproduction or use of rare or valuable material; to make special quotations on material involving unusual difficulty in copying; and to charge higher fees to commercial organizations.
